## **IV.** Approval of Minutes:

Regular Meeting Minutes – Director Priesmeyer made a motion to accept the minutes as presented. Vice President Raun seconded. All voted for; motion carried.

### V. Manager's Report:

<u>Financial Report</u> – Mr. Hudgins reported a checking account balance of \$41,262.85 and a money market balance of \$541,403.57. A budget vs. actual and a list of total District investments was also presented. Director Wittig made a motion to approve the financial report as presented. Vice President Raun seconded. All voted for; motion carried.

<u>Well Registration Update</u> – Mr. Hudgins presented the Board with a detailed breakdown of current Exempt and Non Exempt Well Information. The current information sheet represents the 2008-2010 permit term water numbers.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the Board with the water levels for December. He will check water levels this afternoon and tomorrow and email the Board a copy of the monitor report.

<u>Water Use Report</u> – Staff presented the Board with a report of the 2007 water usage. Twenty-four percent of the reports were reported on the summary sheet. For the reports submitted after the January 15<sup>th</sup> deadline, Mr. Hudgins will send a documented letter to those in violation of the deadline explaining the consequences according to the District's Compliance and Enforcement Policy.

<u>GMA 15</u> – There isn't much of a change in the status of the GMA 15. Victoria GCD is really pushing for advancement on the GMA's discussion of a desired future condition for the GMA. A meeting is tentatively planned for February.

<u>Upcoming Meetings</u> – Mr. Hudgins will attend the TAGD quarterly meeting in Austin on January 31, 2008.
