After discussion and review, Secretary Weinheimer made a motion to approve the checking account balance, the money market account balance, the investment report, and a list of detailed checks and deposits for the month of September as presented. <u>Well Registration Update</u> – Mr. Hudgins presented the Board with a detailed breakdown of current Exempt and Non Exempt Well Information for the 2011-2013 permitting term.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the Board with the September well monitoring report. Recovery is slow but steady.
