IV. Approval of Minutes:

<u>Financial Report</u> – Mr. Hudgins reported a checking account balance of \$59,662.97 and a money market balance of \$881,735.73. A budget vs. actual and the balance sheet for October were also presented. After discussion and review, Secretary Weinheimer made a motion to approve the financials as presented. Director Berglund seconded. All voted for; motion carried.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monitor well levels as of November 01, 2015. Report shows 59 feet, a small decrease from October 2015. The average of the monitor wells in the critical depletion study area show an increase of 7 feet.

- VI. **Discuss and Approve Authorization to Maintain TCDRS Plan Provisions Plan Year 2016:** Mr. Hudgins presented the board with 9 possible plan provisions for 2016. After review and discussion Vice President Raun made a motion to choose CBGCD match of 175% with a one-time employer contribution of \$10,000 pending approval from Coastal Plains Groundwater Conservation District. If CPGCD does not approve the one-time employer contribution of \$10,000, CBGCD will request approval of CBGCD match of 175% pending approval from CPGCD. Director Berglund seconded. All voted for motion carried.
- VII. **Review CBGCD Rules:** Mr. Hudgins presented the board with information staff has compiled for determining historic use. No action was taken. CBGCD rules committee will meet on November 19.
