I. Call to Order:

The meeting was called to order at 8:00 A.M. by President Gertson.

III. Approval of Minutes:

Secretary Weinheimer made a motion to accept the meeting and permit hearing minutes as presented for November 10, 2020. Director Wittig seconded. President Gertson announced the motion passed without opposition.

V. Manager's Report:

<u>Financial Report</u> – Mr. Hudgins reported a checking account balance of \$350,377.54; a money market balance of \$138,061.33, 2018 CD balance of \$416,469.10; 2020 CD balance \$537,897.48. A budget vs. actual and the balance sheet was also presented. After discussion and review, Secretary Weinheimer made a motion to approve the financials as presented. Director Wittig seconded. <u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monitor well levels as of January 2021. The index well graph shows a three-feet recovery from the previous month of December 2020 (one-foot decline from January 2020). The Lissie transducer shows a similar trend to the index wells. November 2020 bi-annual monitor wells show .5 feet decline from November 2019.
