<u>Financial Report</u> – Mr. Hudgins reported a checking account balance of \$438,715.64; a money market balance of \$137,939.93, 2018 CD balance of \$408,345.89; 2019 CD balance \$537,897.48. A budget vs. actual and the balance sheet was also presented. After discussion and review, Secretary Weinheimer made a motion to approve the financials as presented with staff looking into CPGCD Reimbursement Revenue difference of \$1,256.60. Vice-President Raun seconded. All voted for; motion carried. <u>Quarterly Investment Report</u> – Mr. Hudgins presented the board with the current investments of CBGCD funds. After discussion and review, Secretary Weinheimer made a motion to approve the investments as presented. Vice-President Raun seconded. All voted for; motion carried.

<u>2019 Water Use Report</u> – Mr. Hudgins presented the board with a detailed report of water use in 2019 reporting total water use of 111,820 acre feet.

<u>CBGCD Well Information</u> – Mr. Hudgins presented the board with well information with the new 2020 permit term details.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monitor well levels as of July 2020. The index well graph shows a 5-feet decline from the previous month of June (lower than July 2019 and higher than July 2018). The critical depletion study area monitor wells show a similar trend to the index wells. Mr. Hudgins is continuing work on drilling monitor well replacements.
