I. Call to Order:

The meeting was called to order at 8:08 A.M. by President Gertson.

III. Approval of Minutes:

Vice-President Raun made a motion to accept the meeting and permit hearing minutes as presented for July 14, 2020. Secretary Weinheimer seconded. No opposed votes; motion carried.

V. Manager's Report:

<u>Financial Report</u> – Mr. Hudgins reported a checking account balance of \$437,543.24; a money market balance of \$137,968.20, 2018 CD balance of \$408,345.89; 2020 CD balance \$537,897.48. A budget vs. actual and the balance sheet was also presented. After discussion and review, Secretary Weinheimer made a motion to approve the financials as presented. Vice-President Raun seconded. No opposed votes; motion carried.

<u>Quarterly Investment Report</u> – No Action.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monitor well levels as of August 2020. The index well graph shows a one-foot recovery from the previous month of July (same level at August 2019). The Lissie transducer shows a similar trend to the index wells.

- VI. **Discussion to Approve Permit Applications:** After discussion and review of the permit application: OP-20080601 for Crowell Brothers, Vice-President Raun made a motion to approve the permit applications as presented. Secretary Weinheimer seconded. No opposed votes; motion carried.

Discuss and Approve Authorization to Maintain TCDRS Plan Provisions Plan Year 2021: Mr. Hudgins presented the board with the plan assessment for plan year 2021 that included the option of adding the optional benefit of a partial lump-sum payment at retirement. After review and discussion, Vice-President Raun made a motion to add the continued optional benefit of a partial lump-sum payment at retirement requiring a retirement plan rate of 5.91% for the 2021 plan year. Director Berglund Seconded. No opposed votes; motion carried.
- IV. Annual Evaluation of District Investment Policy: After review of the district investment policy, Secretary Weinheimer made a motion to approve the policy as presented. Vice-President Raun. No opposed votes; motion carried.

No opposed votes; motion carried.

The following directors voted for: President Gertson, Vice-President Raun, Secretary Weinheimer, and Director Berglund. Director Wittig was absent from the meeting. Motion carried.
