<u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monthly monitor well levels as of August 2022. The index well graph shows .5-foot decline from the previous month of July 2022 and 15 feet lower than August 2021. The Lissie transducer shows a similar trend to the index wells.
