I. Call to Order:

The meeting was called to order at 8:03 A.M. by President Gertson.

II. **Public Comments:**

III. Approval of Minutes:

Vice-President Berglund made a motion to accept the August 16, 2022 meeting minutes with additions to item III. (to be paid the first pay period of 2022-2023 fiscal year) and item XII. (Action taken up between item V. & VI. to allow Director Heskamp to action during the meeting) and permit hearing minutes for August 16, 2022 as presented. Secretary Weinheimer seconded. President Gertson announced the motion passed without opposition.

V. Manager's Report:

Financial Report – Mr. Hudgins reported a checking account balance of \$244,333.88; a money market account balance of \$138,352.00, 2018 CD balance of \$823,821.34; 2020 CD balance \$547,776.70. A budget vs. actual and the balance sheet were also presented. After discussion and review, Secretary Weinheimer made a motion to approve the financials as presented. Vice-President Berglund seconded. President Gertson announced the motion passed without opposition.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monthly monitor well levels as of September 2022. The index well graph shows 3.5-feet recovery from the previous month of August 2022 and 10 feet lower than September 2021. The Lissie transducer shows a similar trend to the index wells.

Director Berglund seconded. President Gertson announced the motion passed without opposition.
- IX. **Discuss the Progress of the DFC Achievement Policy:** Mr. Hudgins presented the board with possible options to develop CBGCD DFC achievement policy. No Action
- X. **Discuss Possible Budget Amendments Regarding 2021-2022 FY Budget:** After review and discussion, Secretary Weinheimer made a motion to approve the following budget amendments: \$3,000 to Vehicle maintenance & Repairs--\$3,000 From GW Modeling/Engineer and \$1,000 to Cell--\$1,000 from GW Modeling/Engineer. Vice-President Berglund seconded. President Gertson announced the motion passed without opposition.
- XI. **Discuss Possible Adoption of 2022-2023 Budget:** Mr. Hudgins presented and discussed the proposed 2022-2023 budget. Secretary Weinheimer made the motion to adopt the 2022-2023 budget as presented which would necessitate a Tax Rate of \$0.00664/100 valuation. Director Heskamp seconded. Discussion to Approve Continuation of Coverage Administrative Agreement with TML Health Benefits Pool Regarding District Health Insurance: Mr. Hudgins presented the board with the 2023 medical, dental, and vision coverage.
