NOTICE IS HEREBY GIVEN to all interested persons:

That the Board of Directors of the Coastal Bend Groundwater Conservation District ("CBGCD") will hold public hearings on applications for Operating Permits on August 11, 2020 at 8:00 a.m., at the Coastal Bend GCD, 109 E. Milam, Wharton, TX 77488. **An urgent public necessity exists requiring the District to alter public hearing procedures due to COVID-19 pandemic.** This public hearing will be conducted via audio and video conference call pursuant to Texas Government Code, Section 551.125, and as modified by the Governor of Texas who ordered suspension of various provisions of the Open Meetings Act, Chapter 551, Government Code, effective March 16, 2020, in accordance with the Texas Disaster Act of 1975 (see the Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas).

The Regular Board Meeting will be held immediately following the public hearing scheduled at 8:00 a.m.
