IV. Approval of Minutes:

V. Manager's Report:

<u>Financial Report</u> – Mr. Hudgins reported a checking account balance of \$226,532.77; a money market balance of \$383,075.25; and CD balance of \$500,000.00. A budget vs. actual and the balance sheet for December was also presented. After discussion and review, Director Berglund made a motion to approve the financials as presented. <u>Quarterly Investment Report</u> - Mr. Hudgins presented the board with the current investments of CBGCD funds. After discussion and review Secretary Weinheimer made a motion to approve the investments as presented. Director Berglund seconded. All voted for; motion carried.

<u>Well Monitoring Update</u> – Mr. Hudgins presented the board with the monitor well levels as of January 01, 2017. The index well graph shows 2 feet average recovery from November. The critical depletion study area monitor wells shows the same recovery.
